Applicant must be at least one quarter (1/4) Jemez, recognized under the Jemez Pueblo Census Office, enrollment will be verified by the tribal enrollment office, if you are unsure of your enrollment status please contact the Jemez enrollment office at 575-834-0056. **CIB number must contain the following JEM-XXXX. Application WILL NOT be considered without a current CIB.**
- \_\_\_ 3. **A photo** (original or copy) of the applicant- photo must be at least 2.5 X 3.5, larger photos are acceptable.
- \_\_\_ 4. **Two letters of recommendation** written by any of the following: teachers, counselors, current/past employer or tribal leadership.
- \_\_\_ 5. **A copy of letter of acceptance** from the accredited two or four-year institution to attend.
- \_\_\_ 6. **An official transcript** from high school or college last attended. **Must be submitted after each semester.**
- \_\_\_ 7. **A one page, typed personal statement** detailing your career goals, personal interests and how you will use your education to benefit the Jemez community. This personal statement should be clear, typed in essay format, and signed.
- \_\_\_ 8. **Semester course schedule.** Applicant must maintain full-time status in accordance to institution's policy.
- \_\_\_ 9. **Continuing Applicants** see continuing student scholarship requirements Section A-G

## **FINANCIAL NEED SCHOLARSHIP REQUIREMENTS (regionally accredited schools only, see list on last page)**

10. **Applicant must fill out the Federal Application for Student Aid (FAFSA)** and any supplemental forms in the financial aid office of the accredited institution to attend. This includes PELL, SEOG (supplemental education opportunity grant) and other grants available.

12. **Pueblo of Jemez Tribal Needs Analysis Form** (see last page) to be completed by the financial aid office of institution to attend/attending, must be completed and submitted at the end of **EACH SEMESTER**

## **CONTINUING STUDENT SCHOLARSHIP REQUIREMENTS**

- a. **Pueblo of Jemez scholarship application form** must be filled out completely signed and dated.
- b. A copy of letter of acceptance from the accredited two or four-year institution to attend, **IF student has transferred.**
- c. An **official transcript** from college attended.
- d. March 1 of every term student should fill out Federal Application for Student Aid (FAFSA).
- e. **Semester course schedule.** Applicant must be enrolled in twelve credit hours per semester,
- f. **Pueblo of Jemez Tribal Needs Analysis Form** (see last page). **ONLY** if applying for the financial need based scholarship. Must be completed each semester (Fall and Spring)
- g. A copy of a current Certificate of Indian Blood from the Pueblo of Jemez Census Office (*if a new CIB has not yet been submitted*). Applicant must be at least one quarter (1/4) Jemez, recognized under the Jemez Pueblo Census Office, **enrollment will be verified by the tribal enrollment office, if you are unsure of your enrollment status please contact the Jemez enrollment office at 575-834-0056.**
