## State of New Mexico Indian Affairs Department Congratulates the Pueblo of Jemez as They Connect to Broadband Internet



Pueblo of Jemez Governors meet with the New Mexico Indian Affairs Department (IAD) Cabinet Secretary, Lynn Trujillo.

In 2016, the Pueblo of Jemez began building the Jemez Pueblo Tribal Network (JPTN). The goal was to connect fast broadband internet to its schools, library, tribal government departments, programs, and residents. The Pueblo of Jemez secured Educational Rate (E-Rate) funding from the Federal Communications Commission (FCC), which provided the JPTN the opportunity to connect Fiber for high-speed internet at the Jemez Library, San Diego Riverside, and Walatowa High School Charter Schools.

According to a press release shared from the State of New Mexico Indian Affairs Department (IAD), the state provided "\$1.3 Million in Capital Outlay and an additional \$1.4 Million from the state's allocation of CARES Act funds for this project. The Pueblo of Jemez leveraged state, federal and private donations to fully fund this initiative." The press release also shared thoughts from tribal leaders, "The Pueblo of Jemez has worked diligently to develop the Jemez Pueblo Tribal Network to provide Broadband - high-speed connectivity through fiber-optic connections and wireless networks to ensure our people have the tools necessary to address pandemic issues and pursue further education and career opportunities," said Pueblo of Jemez Governor Michael Toledo, Jr. (State of New Mexico Indian Affairs Department, 2021)

# State of New Mexico Indian Affairs Department Congratulates the Pueblo of Jemez as They Connect to Broadband Internet Continued...

On Friday, March 5, 2021, the Pueblo of Jemez Governors met with the New Mexico Indian Affairs Department (IAD) Cabinet Secretary Lynn Trujillo. They toured the Bigbyte.cc Corp data center, which is JPTN's signal distribution frame located in Albuquerque, NM. This frame is mirroring a smaller piece of equipment at Jemez Pueblo.

With the assistance of i9 Technologies, which helps with the program's engineering and deployment, the Jemez Pueblo Tribal Network is currently online, though not available to all Tribal members at this time. Homes are being brought online in phased groups, and individual households will be notified when service has been activated. Please note that there may be intermittent outages as they continue to work to activate all services fully. The Jemez Pueblo Education Department Director, Kevin Shendo, recently thanked the community via email for their continued support and dedication to this overall tribal effort. "This is only the beginning, and there is much more to be realized. We hope you can champion the efforts put forth this year. To support the expansion and further development of the Jemez Pueblo Tribal Network," said Kevin.

# Pueblo Woman Making Strides in her Community Officer Marlinda Pecos



Walatowa tribal member Marlinda Pecos becomes one of the first certified female officers for the Pueblo of Jemez Police Department. Her parents are Mark Pecos and Virginia Fragua. Marlinda grew up in Walatowa with a passion for serving her community. She attended elementary in Jemez and attended Santa Fe Indian School. She received a scholarship for cross country at New Mexico Highlands University and was a softball team member. Marlinda received a Bachelor of Science degree in Kinesiology from New Mexico Highlands University and is currently employed by the Pueblo of Jemez Police Department. To become a certified officer, Marlinda dedicated her time to become physically and mentally fit. She attended the Indian Country Police Officer Training Program in Artesia, NM, for 14 weeks.

As a certified officer of the Jemez Police Department, Officer Pecos serves the Jemez Pueblo jurisdiction. When asked what made her want to become a Police Officer, Marlinda expressed the following:

"I wanted to serve my community in the hope of motivating the youth and females to pursue a career in law enforcement. My mom has always instilled in me that if you set your mind and heart to a goal, it will come. She tells me to take it day by day. Coaching the Walatowa Running Club has also had a deep influence on who I am today. Preaching to the youth about success, determination, pride, commitment, and patience made me want to choose a career that only a few can pursue. Practice, practice, practice is what I would tell the kids. The kid's endless stories about someday wanting to become a coach made me want to set the goal higher. I was once told that we live on a ladder. You set your goal and make your way to the top. My goal was to get a bachelor's degree. But the overall goal can be to get a master's or doctrine degree. Determination will help get you to where you want to be. I encourage everyone to keep striving...Why not? The sky is the limit."

Officer Pecos shares some insight to females who might be embarking on a path similar to hers, "I would say challenge yourself. Many women are going into congress, and women can be just as successful."

# Jemez Pueblo Tribal Network (JPTN)

#### **Home Internet Installation**

**Please note:** For the next few weeks there may be intermittent service interruptions as JPTN continues to refine the infrastructure that services each home. Additionally, as they finalize the network configuration, the JPTN team may have to visit homes in the future to fine-tune items such as alignment to the towers which provide wireless service. Excuse the dust!

Technicians have installed a small Wireless radio outside each home and have brought a cable inside the house. Attached to this cable is a small router called an "AirCube," which looks like the device shown below.



The AirCube powers the outdoor wireless radio and provides Wireless Connectivity (Wifi) into your home. On the bottom of this AirCube, there is a label that looks similar to the following:



Your SSID (The network name you should connect to) will be "AirCube-XXX," where "XXX" represents the last three alpha-numeric (Letters and Numbers) of the MAC portion of this label. The Wireless Password that should be used to connect your laptops and phones will be the letters and numbers to the right of the "WPA2" label. Note that the password is CASE SENSITIVE. This means that upper-case and lower-case matter!

Important: Do not use that literal "XXX" as your AirCube SSID (Network Name) when connecting your devices. The Last three letters or Numbers of the Mac address located on the bottom of the AirCube under the line that begins with "MAC:" is the proper value to use when connecting each in-home network. It will not be "XXXXXXXXX"."

## **Basic Information / General Troubleshooting.**

- 1. Please ensure you leave the Aircube plugged throughout the day and evenings as the JPTN teams work to stabilize the network (Engineers are working around the clock and need to ensure that disconnections are kept at a minimum). Please note that these devices consume very little electricity.
- 2. If you choose to unplug your AirCube, please ensure that the Ethernet Patch Cable (the network cable from the jack on your home to your AirCube router) remains in the same pot/jack it was when the installer left your home. On your Air Cube, the cord from the wall should go into the "WAN" port (Also labeled 24V PoE OUT). It should have a blue outline, as shown in this photo.
- 3. Once the client has been notified that their service has been activated and subsequently experienced connectivity problems, please try to reboot the AirCube before calling for additional assistance. Rebooting may be accomplished by unplugging the round connector shown in the above picture (power cable) for 30 seconds, then plugging the power cable back into the AirCube Unit.

Speed of internet is 25Mbps download / 3Mbps upload.

Internet service is free of charge during these COVID times.

#### FROM THE GOVERNORS

# Memorandnum on Burning Permits To: All Pueblo of Jemez Community Members

Starting immediately and extending through June 30, 2021, no formal burning permits will be required to burn agricultural waste associated with field clearing. In keeping with the Public Health Emergency for the Pueblo of Jemez and the safety and well-being of our tribal members, we are temporarily lifting burn permits to meet the agricultural field preparation needs. This will minimize person-to-person interactions in tribal offices and any associated risks of spreading the Covid-19.

We understand the need for everyone to prepare their planting fields. Providing for our families and traditions through our crops is important. It is paramount that all burning be done with extreme care. It is important to note that firefighting resources are scarce due to the Covid-19 pandemic.

While this memo temporarily allows tribal members to burn without a burn permit, all agricultural and ditch burning must adhere to the following rules while burning:

- Do not burn on windy days. Weather fluctuations such as sudden gusts of wind or changes in direction can quickly turn an agriculture/ditch fire into a wildfire.
- The ground around the burn site should be surrounded by gravel or minimal soil (dirt) for at least five feet in all directions. Clear all vegetation before burning.
- A safe site should be far from power lines, gas lines, telephone boxes, buildings, automobiles, equipment, and overhanging tree limbs. It should have vertical clearance at least three times the pile's height, as heat from the fire extends far past the actual flames.
- For larger areas, make a disk around the field to create a fire break before burning.
- Remain with your burn at all times. Watch the direction of your smoke. Smoke can create a hazard when blowing across roads or highways by limiting driver's visibility, which could cause a vehicle accident.
- Attend your burn until it is entirely out. To ensure the fire has been completely extinguished, douse the fire with water or turn over the ashes with a shovel. Repeat several times. Check the burn area regularly over the next several days, especially if the weather is warm, dry, or windy.

#### Penalties for violation:

In keeping with Jemez Tribal Code Section 3-2-48, whoever shall violate the above shall be deemed guilty of the offense and upon conviction thereof be sentenced to jail for a period not to exceed ninety (90) days or to a fine not to exceed One Hundred Dollars (\$100.00) or both.

The JHHS Transportation Services Program is for non-emergency Medical Appointments such as Specialty Medical Care, Dialysis, Physical/Occupational Therapy, Eye Appointments, etc.

How can I get a ride to my Dr.'s appointment? Follow the steps below.

1. Call the Jemez Health Clinic at (575)834-7413: to request your medical transportation through Purchased and Referred Care (PRC): ask to speak to PRC staff.

- If the above staff are not available, ask to speak to another PRC staff.
- Call 24-48 hours before your appointment date within Albuquerque, Rio Rancho, and Bernalillo areas.
- **2.** Local medical transports to the Clinic: Call the Transportation office at (575) 834-1001, One-hour before your appointment time. (pick-up time is always 15 minutes before your appointment).
- 3. Cancellations of all transports: Call one hour before your pick-up time.

# JEMEZ ENROLLED PATIENTS RESIDING OUTSIDE OF SANDOVAL COUNTY ARE NOW ELIGIBLE FOR PRC COVERAGE!

In coordination with the Jemez Pueblo Tribal Council and Department of Health and Human Services (**DHHS**), this coverage is now eligible for Purchased/Referred Care (**PRC**) coverage for your medical care.

#### These criteria need to meet:

- You must reside within the State of New Mexico.
- You must be enrolled as a Jemez Tribal member and have an updated CIB which shows ¼ degree Jemez blood.
- IF you have not been to the Jemez Health Clinic within the last five years, your patient record needs to be updated for the clinic staff to process the referral and payments.
- If you have an Emergency visit/Urgent Care Visit, please notify Marina Toya @ 575 834-3172 within 72 hours of your visit. If you do not inform PRC, your bill will not be covered under this fund, and you will be financially responsible for your medical bills.
- If further care is needed after your emergency visit, please schedule with our providers, and they will initiate the specialty referral if required.
- JHHS Medical providers must initiate all referrals.

Important information from the Realty Office regarding Electrical/Sanitation hook up to new and existing homes or structures. If you or anyone you know would like the Jemez Mountain Electric Cooperation (JMEC) to connect electricity or the Indian Health Services (IHS) to hook up water or sewer lines to a new or existing structure, please call the Realty office. The Pueblo of Jemez Realty office has a set procedure when working with JMEC and IHS; before a connection can happen, all proper documentation must be in place.

Realty has had a few cases where tribal members did not come to the office to obtain proper documentation, and this caused a delay in their services. To cut down on wait time and to better assist you, Realty should be informed as soon as possible of utility connections.

If you would like more information on the Request for Utility form, please call Realty Office at 575-834-1205, or for further questions about the procedure, call the Public Works Director, Todd Loretto, at 575-834-7942. If no one answers, please leave a voice mail, and we will get back to you as soon as we can. Please be mindful of the Pueblo's current stance on COVID-19 precautions. These safety protocols have the Realty Office closed to walkins. We are only accepting appointments set in advance or the capabilities of GoToMeeting or Zoom meetings.

# NATIVE AMERICAN VOTING RIGHTS PROGRAM REGISTRATION INFORMATION

### **Voter Registration Eligibility Requirements**

To register and vote in New Mexico, an applicant must be:

- A resident of New Mexico
- A citizen of the United States
- 18 years or older at the time of the next election
- The individual has not been denied the right to vote by a court of law due to reason of mental incapacity
- The voter has not been convicted of a felony. In that case, they must have completed all of the terms and conditions of parole or supervised probation or have had the conviction overturned on appeal.
- Have a current or expired New Mexico state I.D. (like a driver's license). The voter can register for the first time or make changes to their registration—like name, address, or party affiliation—easily using the online system.
- If a voter changes their name or moves, they must fill out a new voter registration form and submit it to their local County Clerk's Office or the Secretary of State's Office. They must also fill out a new form if they want to change their party affiliation.
- Suppose a person doesn't have a state-issued I.D. or would prefer to register by mail. In that case, they can pick up a voter registration application form or print the national form online, fill it out, then mail it to the New Mexico Secretary of State's Office or the local County Clerk's Office. Throughout the next five years, Congress continued to pass joint resolutions designating a week in March as "Women's History Week." In 1987 after being petitioned by the National Women's History Project, Congress passed Pub. L. 100-9 designated the month of March 1987 as "Women's History Month." Between 1988 and 1994, Congress passed additional resolutions requesting and authorizing the President to proclaim March of each year as Women's History Month. Since 1995, presidents have issued a series of annual proclamations designating the month of March as "Women's History Month." These proclamations celebrate the contributions women have made to the United States and recognize the specific achievements women have made throughout American history in various fields.

They are in mental health centers and private practices, assisting people to overcome mental illnesses such as depression and anxiety and substance use disorders. They protect children from neglect and abuse and help form new families through adoption. Social workers are in hospitals, assisting patients in getting the best possible care not only while in treatment but when they return to their families and communities. They help those cope with the loss of loved ones. The POJHA is in the process of conducting a Housing Needs Assessment to help us plan and understand the housing needs and challenges in our community. The assessment will help us strategically plan for short- and long-term goals. Our assessment data will help seek potential funding sources to meet our housing needs and challenges. #### **Spring Maintenance**

It is that time of the year again – Spring Cleaning! As a responsible homeowner or tenant, we must perform spring maintenance and clean on an annual basis. If you are like most people, spring cleaning can be a difficult activity to start, as most of us are busy with work, school, kids, and other activities that we would rather do than clean. However, spring maintenance is one of the most critical aspects of keeping your dwelling in good condition.

Before beginning any maintenance activity, please take all necessary safety precautions when performing any maintenance type around your dwelling. Here are some areas to keep in mind when it comes to spring cleaning:

- Clear clutter, gutters, leaves, and debris that build up during the winter months.
- Check for signs or indications of a pipe burst.
- Visually inspect the roof for any signs of damage or repairs needed.
- Inspect any damages near or around windows and doors.
- Check weather stripping, caulking, and repair or replace, as necessary.
- Inspect the home for any rodents or bug infestations.
- Clear any obstacles or obstructions from entry areas for ease of entry and exit in emergencies.
- Clean and organize your cabinets or pantry areas. Discard any expired or unwanted items.
- Assess your electrical outlets to ensure they are working properly.
- Clean and flush your water heater. If you are uncertain how to clean your water heater, please contact us, and we can provide recommendations.

### **CARES Act Funding**

The minor rehabilitation services may include but are not limited to the following: water heater, exterior door, weatherstripping, kitchen sink or bathroom lavatory, toilet, grab bars, and plumbing issues. This list is not all exclusive, so please contact our office for more information. POJHA requires an application to be completed for eligibility purposes prior to scheduling an assessment and work. 
#### **Limited In-Person Services**

The Planning Development and Transportation Department (PDTD) is working on numerous infrastructure improvement projects. Below are the project status updates.

#### NM-4 Multi-use Pedestrian Trail

The NMDOT awarded a \$4.7 Million Grant to the Pueblo to design and construct a multi-use pedestrian trail along the NM-4. The project entails planning, designing, and creating a 1.9-mile pedestrian trail between the Pueblo Place Housing Subdivision and Bear Head Canyon Road. This project will provide safe pedestrian passage between many community services and residences located along the NM-4. The preliminary engineering is currently in progress.

# Tribal Administrative Complex Parking Lots/Sheep Springs Way

The project will construct the following improvements:

- · Grading, paving, and striping all parking lots and the Sheep Springs Way entrance at the south intersection with NM-4,
- · Widening Sheep Springs Way to two lanes,
- · Installation of a retaining wall on the west side of the clinic,
- · Installation of detention ponds east of NM-4 and south of the clinic, and
- · Installation of landscaping and lighting.

The project will also add additional parking spaces, ensure ADA compliance, improve traffic flow, and increase pedestrians' and drivers' safety. Construction is underway and will be completed in spring 2021. Alternative parking areas are located at the Senior Center and the Pueblo Place Housing Subdivision, with a daily shuttle service at Pueblo Place in the mornings and evenings.

## **Emergency Modular Buildings**

The project will design and construct seven emergency modular buildings west of the Jemez Community Wellness Center to conduct COVID-19 testing, facilitate distance learning, and improve employees' telework capabilities during a public health emergency. The site work was completed, and the buildings are currently being manufactured and installed. The project will be completed in spring 2021.

#### **Road Maintenance**

The road maintenance team works diligently to improve roadway and parking lot conditions throughout the Pueblo. The team has completed or is currently working on the following projects:

- · Conducting routine road maintenance on village roads,
- · Grading irrigation ditch roads,
- · Installing speed humps,
- · Clearing snow and ice,
- · Patching potholes with asphalt, and
- · Replacing damaged signage.

# Dr Nilla H. Vallo

Dr. Nilla H. Vallo, PhD., was a special and important lady who shared many memories with people in Walatowa. She earned her Ph.D. in early childhood education from the University of New Mexico in 1988. She mentored teachers guiding young children in daycare settings, Headstart, schools, and New Mexico and Arizona colleges. She advocated for bilingual teaching, native-cultural literacy and pioneered learning via interactive video. She helped administer early childhood education programs in the Pueblo of Jemez before retiring. She settled in Walatowa in the 1970s with her husband, MSGT Lawrence J. Vallo, a retired USAF pilot [Walatowa-Acoma]. She moved to Rio Rancho in the 2000s after his death. She is survived by three adult children and spouses, grandchildren, great-grandchildren, as well as her many other children whose lives she touched in her personal and professional life. Her family reported her passing peacefully on February 3, 2021, from natural aging. She was 90 yrs old. A virtual memorial service has been conducted.
