Re: Continuation of Lockdown until May 31, 2021

As of March 30, 2021, the Pueblo of Jemez currently has zero (0) active COVID-19 cases and zero (0) households in quarantine. The Governors have decided to extend a modified Jemez Community lockdown until May 31, 2021. This modified lockdown is considered Phase 2 Lockdown. We thank the community for your continued vigilance and willingness to practice COVID-19 prevention efforts as well as receiving the COVID-19 vaccine.

Easter Sunday: Gatherings will not be allowed or tolerated. Established lockdown protocols will remain in place.

Phase 2 Lockdown: We understand that you need to leave the pueblo for essential needs and you will still be permitted to go through the checkpoint based on the following modified schedule effective Monday, April 5th, 2021:

Fully immunized only!	Saturday

Current established restrictions will remain in place until Monday, April 5th, 2021. This Saturday, April 3rd, will NOT be an essential day for fully immunized individuals.

The following REVISED guidance is to be followed:

- Lockdown on Thursday, Friday and Sunday will be very strict and only governor permitted access will be granted.

- New Saturday Access: Each person must show proof of vaccination status (card) of full immunization. Failure to do so will eliminate permissible access. Children will not be allowed access on Saturdays, but will be allowed Monday, Tuesday and Wednesday.
- **Full immunization:**
 - Pfizer or Moderna – Full immunization is considered for those that have received two doses of Pfizer or Moderna AND two weeks has lapsed after receiving the second dose.
 - Johnson & Johnson - Full immunization is considered for those that have received one shot of the Johnson & Johnson AND two weeks has lapsed after receiving the dose.
 - Checkpoints will be checking dates for each individual person.
- Non-resident Tribal members: Non-residents will not be allowed in the Pueblo unless an approved pass is obtained from the Governor's office. Having a vaccination card does not grant "permissible" access into the Pueblo for non-resident members.
 - Friends of family, boyfriends or girlfriends whom are not Jemez tribal members will not be allowed to visit or reside. Such persons will be removed by order of the Governors.
- ALL vehicles will be required to stop at each checkpoint to state the person's case even if the worker is busy. Each checkpoint worker is also required to stop each vehicle to hear each person's case.
- You will be turned around and not allowed to leave the Pueblo if your travel is determined to be unnecessary/non-essential.
- Checkpoint passes will be required for non-essential days and will be approved/disapproved by the Governors on a case by case basis. Passes can be requested at #575-834-7359.
- If you are an essential employee, working for the Pueblo of Jemez, or outside, we request an updated signed letter from your employer to show at the checkpoint. Bring your work ID.
- Wood hauling/hunting will be allowed on your designated essential day and weekend with proof of a permit.
- Trash hauling will be opened on Saturdays and Sundays, from 10am-2pm, on Green Acres road. Only "to and from" access will be allowed.
- Entry/exit for farming or farming related activities will be allowed. If gas/diesel is needed, proof of gas can or vehicle low fuel status must be provided.
- As athletics begin for high school, students will be allowed to attend practice if proof of registration or schedule is provided.
- Parking at road closures or barricade areas are not allowed. Citations or boots on vehicles will be assessed for such actions.
- Curfew is 8:00 PM – 5:00 AM, seven days a week. Be at home within this time period.

The Jemez COVID-19 Response team is working diligently on getting our community vaccinated to fight the spread of this pandemic. Currently, we are in the **Red** status. Each community/tribal member holds a responsibility in ensuring safety of the community during this pandemic. We ask for your support and consider receiving a vaccine as it will help in minimizing the impact of COVID-19 in the Jemez community. We currently have the Johnson & Johnson vaccine available to tribal members only, which requires only one shot to be administered. Please know we are doing our best to gather data of vaccination status for community members residing in Jemez.

Conditions: By authority of the Governors, the below listed conditions must be followed for the community to remain in Phase 2 Lockdown. Any broken condition listed below will reinforce Phase 1 lockdown. Obeying said conditions will prompt Phase 3 of lockdown to be implemented.

- Masks must always be worn! No one is exempt from not wearing a mask. Receiving a vaccination shot does not “earn” one the right to no longer wear a mask.
- IF the Pueblo of Jemez has 5 active COVID-19 cases and/or 10 households in quarantine, the Pueblo of Jemez will immediately revert back to Phase 1 Lockdown (current lockdown restrictions).
- Excessive disrespect and disobedience of checkpoint workers by community members.
- No out of state travel!
- Community members abuse set conditions and revised guidelines.

Hunters Guidance:

- Only licensed hunters will be allowed beyond the Checkpoints. Licenses will be checked.
- Unlicensed children or adults will not be allowed.
- Tribal licenses will not be issued, only licenses from New Mexico Game & Fish will be recognized.
- Hunters in a vehicle must be from the immediate household, limit 3 hunters per vehicle.
- Only day hunts will be allowed, hunters must return by curfew each day.
- It is important that hunters limit outside contact throughout the day, therefore, hunters must travel directly from the community to their hunt areas.
- We highly encourage hunters to bring with them all food items to be prepared at home.
- We encourage to have little to no interaction with other hunters or campers in hunt areas.
- Use of alcohol and illegal drugs is strictly forbidden and will not be tolerated.
