Responsible for providing law enforcement services to the community within the jurisdiction of the Pueblo of Jemez.

Work is subject to performance under exposure to adverse environmental conditions, bodily fluids, bio hazards, gases, noxious odors, and noise and traffic conditions.

## **ESSENTIAL FUNCTIONS:**

- Performs duties including crime prevention, detection and investigation of victim-related crimes
- Assist with community education and awareness activities and specific staff training and policy development on victimization issues
- Critical Incident Debriefing for law enforcement and Tribal officials
- Performs patrol duties, including preservation of the peace, arrest or apprehension of violators, and assistance to citizens, visitors and employees with focus on victim-related incidences
- Work cooperatively with the Jemez Social Services program through all stages in an investigation process and trial process on victim-related cases
- Collaborates with Social Services, Tribal Courts, Behavioral Health, and other programs in case conferences, mutual training, clarification of roles and responsibilities, and development of policies and procedures
- Responds to calls within the exterior boundaries of the Pueblo of Jemez concerning felonies, emergencies, traffic accidents, drug charges, altercations and misdemeanors under Federal, State, local and tribal laws; investigates, apprehends, arrests, and detains all persons charged with violations and highlighting victim-related incidences or situations
- Enforces Federal, State, and Pueblo of Jemez laws and ordinances, rules and regulations relating to law enforcement and the physical protection of citizens, visitors and employees; the protection of property; the protection of the civil rights of all individuals; and the preservation of law and order; serves as a deterrent to crime and other violations of laws, rules, and regulations
- Participates in grant-funded initiatives such as saturation patrols, alternatives to incarceration, DWI checkpoints, victim-related welfare checks, joint-response, and joint interviews, investigations and prosecutions.
- Makes arrests in cases of crime or misdemeanors personally witnessed; takes persons arrested to appropriate authorities for booking or formal charging
- Serves Federal, State, or local or tribal warrants, subpoenas and other court papers; testifies at hearings and trials as an expert witness in Federal, State, local or tribal courts as required
- Prepares and submits reports of incidents highlighting victim-related cases, daily and weekly activities, and narratives and statistical reports as required
- Performs investigative work
- Testifies in official capacity at Tribal, State, and Federal hearings
- Provides non-enforcement services to the Pueblo of Jemez community i.e. community violence prevention events and projects and participating in conference preparations, and other initiatives, which may be directly or indirectly related to the function of law enforcement
- Contributes to the overall quality of the unit's service provision by developing and coordinating work teams and by reviewing, recommending and implementing improved victim-related policies and procedures
- Represents the Pueblo with dignity, integrity, and a spirit of cooperation in all relationships with staff and the public

### REQUIRED KNOWLEDGE AND SKILLS:

- Experience working in Tribal communities and cultural sensitivity preferred
- Laws, regulations, practices, and procedures of law enforcement and police work
- Tribal, state, and federal criminal laws, including procedures, regulations, guidelines, and precedents related to admissibility of evidence and prosecution
- Laws, principles, and procedures used in apprehending a criminal suspect, including policies for pursuit and proper use of force and capture
- Investigative techniques to adequately handle complaints and incidents which may entail performing initial investigative actions prior to transferring situation authority to other investigators
